CIRCULAR

Sub: Calculation of grades of II & IV Semesters of U.G and II Semester of P.G
Programmes students-reg.(Both Regular and Distance Education)

With reference to the above, the following is the method of calculation of grades for the students of II & IV Semester of U.G Programmes and II Semester of P.G. Programmes Students.

PROCEDURE FOR CALCULATION OF GRADES FOR CURRENT INTERMEDIATE STUDENTS
(Both Regular and Distance Education)

The grades of all UG and PG students of current semester shall be calculated as follows:

1. Continuous Internal Evaluation (C1 & C2) marks of each course of current semester shall be scaled to a maximum of 50.
 2. Semester End Examination marks of all credit course of the preceding semester shall be scaled to a maximum of 50 and then averaged. If a student has remained absent in the preceding semester, the Semester End Examination marks for that course shall be taken as zero.
 3. The calculated average Semester End Examination marks shall be taken as the Semester End Examination marks for each course of the current semester.
 4. Regulations applicable to minimum Continuous Internal Evaluation, Semester End Examination and total marks for the current semester shall be as per applicable regulations.
 5. Total marks for any course of current **even semester** shall be the sum of Continuous Internal Evaluation of the current semester (scaled to a maximum of 50 marks) and average Semester End Examination marks (scaled to a maximum of 50 marks) of the all the credit courses of the preceding **odd semester**.
 6. Grades shall be assigned based on the applicable regulations.
 7. Where marks require scaling, fractional marks shall be rounded up to the next larger inter.
- The contents of this circular may be brought to the notice of the all the concerned.

NOTE: 1. The candidates who have failed/not appeared in the preceding semester examination, in such cases the students will be permitted to seek admission to next higher semester. However, students must clear the backlog subjects within double the durations of examinations.

Then results of such students of II & IV Semester of UG and II Semester of PG will be processed as per point 01 to 07 immediately after the successful completion their odd semester courses.

2. For Distance Education/Specialised programme Students those who have admitted during the academic year 2019-2020 first cycle of I Semester, their results will be declared based on their internal assessment marks. Based on the internal assessment marks obtained in each paper, that will be aggregated to 100 % (theory).
