STATUTES RELATING TO THE ESTABLISHMENT OF PLATINUM JUBILEE CHAIR ON DR. ZAKIR HUSSAIN STUDIES IN NATIONAL INTEGRATION FRAMED UNDER SECTION 35(n) OF THE KARNATAKA STATE UNIVERSITIES ACT, 1976.

I TITLE AND COMMENCEMENT:

1. The Statutes shall be called " Statutes relating to the establishment of Platinum Jubilee Dr. Zakir Hussain Chair for studies in National Integration.
2. The Statutes shall come into effect from the date of assent of the Chancellor.

II LOCATION: This Chair may be located in the Department of Studies in Humanities/ Social Science; Department of Studies in Law & Education by rotation for a period of 1 year to be decided by the Syndicate from time to time.

III OBJECTIVES:

1. To study the literature of Gandhiji, Pandit Nehru and Dr. Zakir Hussain of pre-Independence and after Independence of India.
2. To study the present position of our country and re-organisation of States.
3. The problem of Northern States such as Punjab, Kashmir, Himchal Pradesh and Assam etc. keeping in view of the National Integration.
4. To study the life History of Dr. Zakir Hussain the former President of India.

IV STAFF: VISITING PROFESSOR:

- 1) There shall be a Visiting Professor/Scholar who shall be appointed on invitation by the Syndicate for a period not less than 6 months and not exceeding one academic year.
- 2) Visiting Professor shall be appointed from among the eminent Scholars in the field of National Integration Studies, Freedom Fighters who are literarily good, eminent writers those who were written during pre-Independence, Ex-Ambassadors and High Commissioners.
- 3) Visiting Professor/Scholar shall be eligible for an honorarium of Rs.8000/- per month and free accommodation in the University Guest House, M.G., Mysore. In case of in-service Professors/Scholars his total emoluments will be protected.
- 4) A contingency grant of Rs.15,000/- will be provided for Visiting Professor/Scholar.

V SCOPE:

1. Holding Lectures not less than 4 in a month by the Visiting Professor on the objectives stipulated in these Statutes.
2. Conducting Seminars, Workshops, Conferences, Study Circles to formulate the objectives of the Statutes.

VI Finance:

The expenditure may be met out of the funds collected to the Platinum Jubilee Celebration of the University.
